PREPARING FOR MAJOR STORMS

Dear fellow home and landowners within the Ranger Drainage District,

Hurricane Ian made landfall in Central Florida on September 28, 2022 and left behind approximately 13 inches of rain on already saturated ground. This rain event, in combination with the summer rains, gave us a total of 53 inches at the end of September.

Over the past several years the District has focused on overhauling and improving the system to prepare for major storms. Every canal, pipe, easement and lake within the District was touched and evaluated in some way. Lake Davis was constructed to aid in additional storage and the redirection of stormwater from Abalone Boulevard to Canal 6. A total of more than \$6 Million in upgrades.

Based on the amount of rain Ian left in a very short time the new system proved to function very well. Within a few hours of the storm passing, water had receded significantly. District staff and engineers were onsite to evaluate the area.

While the system functioned as designed, RDD continues to strive to improve any way we can. We are currently looking at two areas: the Intersection of Maxim Parkway/Bancroft Boulevard and Canal 5.

We plan to make a few minor adjustments in both locations that will provide significant drainage relief.

Lastly, I would like to thank our RDD staff for their daily commitment to hard work and excellence in maintaining the drainage system.

I hope you enjoy this annual newsletter "Water Matters."

FRIENDLY REMINDERS — CONTINUED


- Fishing in District canals and lakes is limited to persons who either own the property that they are fishing on or have written permission from the property owner at the site where they are fishing. Access to the site is limited to that property owner or that property owner's guest who must have written permission.
- Excessive use of pesticides, fertilizers and herbicides placed on your lawn eventually make it to the canals. Excessive nutrients in the canals lead to additional growth and water quality issues. We need your help to maintain our water quality.

PHASE III STREET LIGHTING

In our newsletter last Spring we mentioned the Phase III street lighting project was underway. In this publication we can report that the street lights have now been installed!

The map identifies the locations of lights which are primarily at the major canals. Any other lighting throughout the District that you may see would have been at the direction of Orange County.

FRIENDLY REMINDERS

All fences and most structures require a permit from the District. The permit process allows us to work together to protect the deeded easements that RDD utilizes to perform its maintenance. When fences, structures etc. are installed without permits along the property line, they typically are in violation of the dedicated easements. These obstacles make it very difficult and in some cases, impossible for our equipment to navigate the limited space safely.

- When the natural ground is disturbed for any reason a silt fence must be installed to prevent run off. Notify the District office for more detail on this requirement.
- Mallard Lake is open for fishing to the landowners of the District. Mallard Lake can be accessed from Maxim Pkwy. only, along the RDD easement.

DRIVEWAY PIPES

Driveway pipes are installed at the roadside swales. These pipes are critical to the functionality of the storm water system. There are many locations throughout the District where grass and debris are blocking water from flowing through the pipes. As a reminder, the maintenance of keeping the driveway pipes clear is the responsibility of each homeowner or landowner.

As a reminder, if you are experiencing washouts on the side of the concrete slab around the culvert pipe some low maintenance ground cover may help. One possible solution would be to plant Asiatic Jasmine. This plant will stand up to the Florida heat and is easy to maintain.

WANT TO HELP?

Roadside swales in front of each home are the responsibility of the homeowner to maintain. If this area is overgrown, water cannot flow freely. Upon request various swale locations throughout the District have been cleaned out/regraded and the elevations have been reestablished.

It's crucial that each homeowner maintain the swale by mowing and or weed whacking to keep the area free of obstruction.

Keeping the grass edged along the road is another way to help with the drainage.

This allows the water to flow down the roadside faster and into the drainage system.

MASTER/INTERLOCAL AGREEMENT WITH ORANGE COUNTY

Since the creation of the District back in 1970, many written and "hand shake" agreements with Orange County have been made in respect to who is responsible for certain tasks within the Ranger Drainage District. Throughout time leaders of different departments from Orange County have come and gone and through this transition the duties of each agency became blurred. This past year the District Manager, Engineering Firm and Legal Counsel met and identified duties required of the District in accordance to our operating permit known as the Plan Of Reclamation.

We are pleased to report that an agreement was reached between the District and Orange County within a timely fashion and we now have what we call a "Master Interlocal Agreement" that identifies the responsibility of each agency. The District continues to work closely with Orange County to provide efficient services to our community. With that being said, below is a summary of those duties:

RANGER DRAINAGE DISTRICT

- Maintenance of all primary and secondary canals, flow-ways, lakes and associated water control structures within the District easements
- Maintain and maintenance-grade as necessary all open grassed swales within the County rights-of-ways
- Driveway culvert installations
- Removal of trees, vegetation or other debris within the primary and secondary drainage system
- Mow 17 miles of main canals
- Mow 28 miles of secondary canals
- Mow 73 miles of roadside
- Maintain 17 retention ponds, 11 of those located in The Reserve
- Maintain 174 canal structures
- Aquatic spraying
- Slope mowing

ORANGE COUNTY

- Repair and maintain the County roadways
- Repair and maintain concrete valley gutters, curbs, inlets, underground drainage pipe and culvert crossings of the secondary flow ways located within the public road rights-of-way easements
- Construction, repair, replacement and maintenance of all sidewalks
- Tree and vegetation removal; trash pickup
- Clearing or removal of trees and vegetation from roadway easements that interfere with vehicular or pedestrian use of rights-of-way
- Clearing obstructions from the roadways including gutters, curbs, inlets and underground drainage piping located within the pubic rights-of-way
- Repair or replacement of the primary drainage system that crosses under County maintained rights-of-way
- Provide funding to the District to offset the increased cost of maintaining the unpaved roadside rights-of-way where sidewalks have been installed in the Estate-Area

UNPERMITTED PIPES

REMINDER... any pipe installations must first be approved and permitted by the District.

No direct runoff pipes from any parcel of land into a retention pond, secondary easement or major canal is allowed. All water must flow to the street or retained on property.
