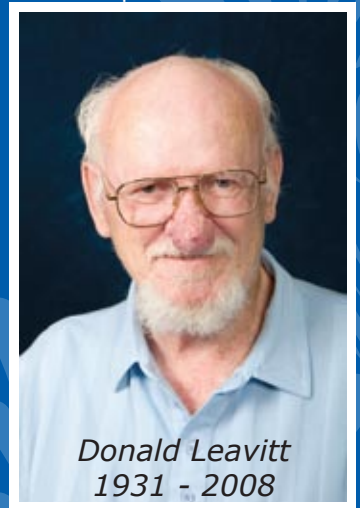


Welcome

UPDATE: May 14 Public Hearing for Proposed Bond

The District's Board of Supervisors has spent much of the past year searching for the best solution to fund our capital improvement projects. These projects include those required by state law and those necessary to relieve and prevent flooding within the District.

The preliminary cost estimate for the most critical projects is approximately \$9.5 million, which would be paid for by the property owners in the District. By taking the life expectancy of the improvements and the associated costs into account, we have determined that issuing bonds for funding is the most cost-effective solution.

The first public hearing to review the proposed bond is scheduled for May 14, 2008 at 9 a.m., to be held at the District office.

What Does it Take to Become a Supervisor?

As the annual District election nears, here is a brief look at the specific requirements a candidate must possess to become a Supervisor:

- Must own land within the District and be a resident of Orange County
- Must attend monthly meetings, occurring the second Wednesday of each month
- Must attend several workshops throughout year, approximately five total
- Must be available to work several hours with the District Manager to tour the District and learn the operations of the District
- Strongly encouraged to attend a week-long conference, held in Sarasota in June, with sessions on the Sunshine Law, Chapter 298 and more
- Should have an understanding of the laws and statutes governing the District, such as Chapters 298 and 189, the St. Johns River Water Management Permit Conditions and the Sunshine Law

RDD Profile: Meet the Experts

We asked Terry Lewis a few questions to better understand his responsibilities to the Ranger Drainage District. Here are his answers:

RDD: Why does the Ranger Drainage District need attorneys?

TL: There are approximately 40 different state laws with which the Ranger Board and District staff must comply. Among the most important are statutes such as the Government in the Sunshine Act, which mandates that all meetings of the Board be conducted in the public with notice to District landowners and the general public; and the Special District Accountability Act, which specifies compliance with other district requirements such as elections, ethics for public officials, financial reporting and audits. The District attorney advises the Board and staff to ensure compliance with these laws.

RDD: What else do you do for the District?

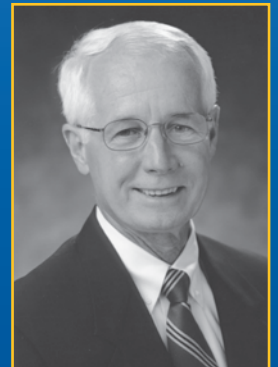
TL: We also assist the District when it becomes involved in litigation with individuals involving matters such as contract compliance, violation of District policies, or negotiations over permits and licenses with other federal, state and local government agencies.

RDD: Do all special districts have an attorney?

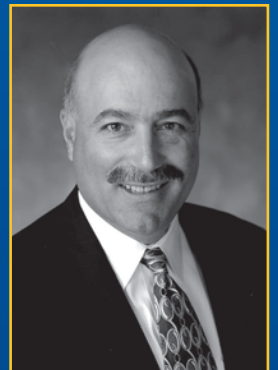
TL: To my knowledge, most, if not all, larger special districts (with more than \$250,000 budgets), who are members of the Florida Association of Special Districts have attorneys to advise them. These districts usually meet quarterly and are involved in matters such as contracting for goods and services with outside vendors.

RDD: How many special districts does Lewis, Longman & Walker represent?

TL: Our firm currently represents about 75 special districts as either general counsel or special counsel. Bill and I do not, of course, directly advise all those districts – we delegate to other attorneys in the firm. We have litigators that normally handle lawsuits and other lawyers that are expert in pensions and retirement issues. We also have a section that has a statewide reputation in environmental and land use law.

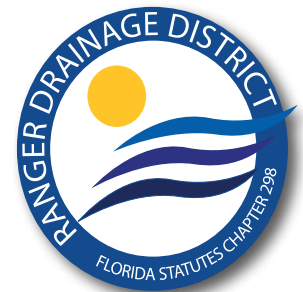
